Dear parents and/or guardians,

If you have a student who takes home a Lebanon Community School Corporation (LCSC) MacBook, this letter contains important information about your responsibility and options to repair and/or replace district-owned equipment.

The repair costs are as follows:

#### **LCSC**

LHS Lost/stolen/unrepairable Computer \$768 + Lost Bag \$33.27= \$801.27 LMS Lost/stolen/unrepairable Computer \$818 + Lost Bag \$33.27= \$851.27 Lost Extension Cord \$7

Missing Keys - Replaceable - \$5 each - As soon as a key comes lose the student should report to AppleCare to have the key reattached, if possible. The Top Case with Keyboard could be damaged when the key first pops off, but continued keyboard use without the key-top virtually guarantees damage to the Top Case with Keyboard costing \$205.95 to repair.

The payment for damages is the responsibility of the parent or responsible party even if insurance is purchased.

All payments for damage are due to LCSC.

#### **Insurance Options**

You should first check with your homeowner or renter insurance agent. You want to ask for coverage on school-owned device, sometimes referred to as personal article coverage. If insurance is available from your agent they must agree to pay the LCSC provided fees and use LCSC repair options listed in this document. We do not honor insurance policies requiring the use of other repair facilities.

The next option is Worth Avenue Group INC (WAG). LCSC has negotiated a \$0 deductible group rate and information is available at <a href="https://gpo.worthavegroup.com/gpo/lebanoncsc-hm">https://gpo.worthavegroup.com/gpo/lebanoncsc-hm</a> and on the page 3 of this letter.

If you elect to purchase coverage from WAG then it is very important for you to read the insurance policy. Three common incidents LCSC parents have been charged for would not have been covered by WAG. This information is from page four of WAG insurance policy in the section titled **Losses We Will Not Cover**.

**Theft From An Unattended Vehicle:** We, Worth Avenue Group INC, will not cover loss or damage that is caused by or resulting from theft from an unattended vehicle except when it is securely locked, its windows are fully closed, and there is visible evidence that entry into the vehicle was forced.

Unexplained Loss or Mysterious Disappearance: We, Worth Avenue Group INC, will not cover loss or damage where the only proof of loss is unexplained or is caused by the disappearance of property without the knowledge as to place, time or manner of its loss. If your property was stolen, you are required to notify the local police immediately upon discovery. This policy does not provide coverage if you fail to notify the police.

Cosmetic Damage: We, Worth Avenue Group INC, will not cover loss for Cosmetic damage. Cosmetic damage means damage or changes to physical appearance of the covered property that does not impede or hinder the normal operational function of the scheduled property such as scratches, abrasions, change in color, texture, or finish.
